# **The David Cox FLAVA 2010 Award**

## **Excellence in Foreign Language Teaching, K-12**

This award recognizes a foreign language teacher in grades K-12 who has demonstrated excellence in foreign language instruction and who may be forwarded as the FLAVA candidate to either the SCOLT or NECTFL Teacher of the Year (TOY) competition and eventually to the ACTFL TOY competition.

### **Criteria for Selection (see rubrics below)**

1. The nominee must be a current FLAVA member. Although not mandatory, membership and participation in either SCOLT or NECTFL are highly desirable.
2. Nominee shall be a full-time foreign language educator in grades K-12 who spends at least fifty-percent (50%) time in direct teaching during 2010-2011 with an expectation of continued direct teaching during the next three (3) years at the K-12 level.
3. Nominee's contributions to foreign language teaching must demonstrate a positive impact on teaching and learning.
4. The nominator must submit evidence of excellence in teaching, including three to five supporting letters, at least one from each of the following constituencies: a current or recent student or his/her parent; a professional colleague; a supervisor.
5. A 500 word first-person statement on the value of learning language and culture.  
With the regional competition in mind, it is recommended that:
  - The nominee in concert with the nominator fill out the linked competencies checklist ([http://www.flavaweb/files/FLAVA\\_Awards\\_CkList2010.pdf](http://www.flavaweb/files/FLAVA_Awards_CkList2010.pdf));
  - Although a teaching portfolio is not expected for this nomination process, the nominee should be willing to create one, starting with the documentation collected in this very process.

### **Procedures for the Nominator**

1. ONLY a supervisor, administrator, or department chair (when there is no supervisory personnel) may nominate an individual and must demonstrate awareness that the candidate may eventually win the ACTFL TOY with its incumbent duties as the ACTFL-sponsored Ambassador for Foreign Languages for the 2011-2012 academic year.
2. The following items must be included in the nominating packet or email with attachments in order.
  - FLAVA Awards Cover Sheet.
  - Nominating cover letter signed by the nominator or by email clearly showing the nominator's institutional address with attached letter.
  - Letter of recommendation from a professional colleague.
  - Letter of recommendation from a supervisor.
  - Letter of recommendation from a current or former parent or student.
  - *Curriculum Vitae* of no more than five (5) pages.
  - Five-hundred-word (500) first-person statement on the value of learning language and culture.
  - Evidence of the nominee's influence on students.
  - Statement of willingness to participate in all required activities associated with the award (form is available on ACTFL website at <http://www.actfl.org> ) including:
    - A commitment to attend the respective regional conference for a personal interview (The regional organization or state association may provide reimbursement of some expenses);
    - If selected as the regional winner, a commitment to attend the ACTFL Annual Convention (hotel, registration, and transportation are paid by ACTFL); and
    - Willingness to serve as a spokesperson for the profession, based on availability.
  - An assortment of portfolio-like documents, which may include:

- Evidence of the nominee's impact on foreign language programs within the school or district.
- Evidence of classroom competence (see [http://www.flavaweb/files/FLAVA\\_Awards\\_CkList2010.pdf](http://www.flavaweb/files/FLAVA_Awards_CkList2010.pdf)).
- Evidence of service to professional organizations.

## **The Marshall Brannon FLAVA 2010 Award Excellence in Foreign Language Teaching, Post-Secondary**

The post-secondary teaching award recognizes a foreign language educator who has demonstrated excellence in foreign language education and who may be forwarded as the FLAVA candidate to either the SCOLT or NECTFL Teacher of the Year (TOY) competition perhaps eventually to the ACTFL TOY competition.

### **Criteria for Selection (see rubrics below)**

1. The nominee must be a current FLAVA member. Additionally, membership and participation in either SCOLT or NECTFL or both is highly desirable.
2. Nominee shall be a full-time foreign language educator who spends at least fifty-percent (50%) time in direct teaching during 2010-2011 in a post-secondary institution and who expects continued direct teaching during the next three (3) years at this level.
3. Nominee's contributions to foreign language teaching must demonstrate a positive impact on teaching and learning.
4. The nominator must submit evidence of excellence in teaching, including three to five supporting letters, at least one from each of the following constituencies: a current or recent student; a professional colleague; a supervisor.
5. A 500 word first-person statement on the value of learning language and culture.

With the regional competition in mind, it is recommended that:

- The nominee in concert with the nominator fill out the linked competencies checklist ([http://www.flavaweb/files/FLAVA\\_Awards\\_CkList2010.pdf](http://www.flavaweb/files/FLAVA_Awards_CkList2010.pdf));
- Although a teaching portfolio is not expected for this nomination process, the nominee should be willing to create one, starting with the documentation collected in this very process.

1. Any colleague may nominate an individual but both the nominator and the nominee must be aware that the candidate may eventually attain the ACTFL TOY status with its incumbent duties as the ACTFL-sponsored Ambassador for Foreign Languages for the 2011-2012 academic year.
2. The following items must be included in the nominating packet or email with attachments in order.
  - FLAVA Awards Cover Sheet.
  - Nominating cover letter signed by the nominator or by email clearly showing the nominator's institutional address with attached letter.
  - Letter of recommendation from a professional colleague.
  - Letter of recommendation from a supervisor.
  - Letter of recommendation from a current or former student.
  - *Curriculum Vitae* of no more than five (5) pages.
  - Five-hundred-word (500) first-person statement on the value of learning language and culture.

  - Learning materials authored, edited, or produced (including textbooks, computer programs, and other materials).

## **The Helen Warriner-Burke FLAVA 2010 Distinguished Service Award**

This award recognizes foreign language educators in Virginia who have made outstanding contributions to the profession.

### **Criteria for Selection**

1. The nominee must be a current member of FLAVA.
2. The nominator must submit evidence of outstanding contributions such as letters of support from students, colleagues, administrators or institutional officers.
3. The nominator must submit evidence of service to the school district or institution, community, and state, as well as to state, regional, and national professional organizations.
4. In the case of administrators or supervisors, the nominee must submit evidence of instructional leadership.

### **Procedures for Nominations**

1. Individuals or representatives of institutions/organizations may nominate post-secondary Educators.
2. The items listed below must be included in the nominating packet. Arrange them in the following order:
  - a. FLAVA Award Cover Sheet.
  - b. Nominating cover letter signed by the individual or organization making the nomination. If delivered electronically, it must clearly originate from the nominator's institutional email address.
  - c. *Curriculum vita* of the nominee (length must not exceed three pages).
  - d. Letters of support clearly explaining the rationale for the choice of this nominee. These, too, may come via email but must be forwarded with the originating email that clearly displays the writer's current email address, preferably an institutional one.
  - e. Other documentation, e.g., copies of newspaper articles or other materials, if appropriate for the award. Limit to ten (10) such samples. May be scanned.
  - f. Evidence of the nominee's leadership. This evidence should consist of a record of active participation in the activities of various foreign language organizations. This would include not only membership and holding office but also work on committees, significant publications, conference presentations, and other organizational activities.
3. A record of special honors and awards received and a brief description of innovative curricular programs that the nominee has established.
4. Documented recognition of the nominee's professional contributions and leadership by those with whom the nominee has regular contact. This recognition should be expressed in supporting letters from supervisors, colleagues, students, or others who benefit from the nominee's services. These may be submitted electronically along with the originating email address of the writer.
5. Supporting letters from co-workers under the nominee's supervision. Supporting letters should document the nominee's excellence as a teacher and/or professional leader in foreign language education. These may be submitted electronically along with the originating email address of the writer.

## Criteria for Selection **FLAVA 2010 Friends of Education Award**

The FLAVA Friends of Education Award recognizes a business or industry that has made a significant contribution in building a strong foundation of support for foreign language education.

### Criteria for Selection

1. Nominee must be a business or industry that has made a significant contribution in promoting a closer relationship between business and foreign language education.
2. Nominee must show evidence of leadership in bringing together language educators and business communities, or in other ways demonstrating exceptional efforts to link the business world and foreign language education.
3. The nominee may be in corporate, public, or professional service.

### Procedures for the Nominator

Include the following items in the nominating packet in order and may be submitted electronically:

- a. Foreign Language Award Cover Sheet.
- b. Letters of support that clearly explain the rationale for the nomination of the business or industry. If sent electronically, either scan or send with originating email.
- c. Other documentation, e.g., copies of newspaper articles or other materials of support for the award. May be scanned.

### Deadlines

- Nominations to Chairperson postmarked on or before **September 20, 2010**.
- The award is presented during the FLAVA Conference held during the Annual Fall Conference, October 8-9, 2010, in Richmond.

Finalists, their supervisors, and nominators will receive notification of the final results by the Chairperson of the Awards Committee. All nominees will receive a Certificate of Outstanding Achievement signed by the President of FLAVA and the Chairperson of the Awards and Recognition Committee.
